Public Comment:

- Public Works Report: VC Ryder reported that the speed humps have been re-installed, 10,000 linear feet of road striping has been done, the Willow Pond bench and sign have been installed.

Willow Pond Update: Mayor Weiss stated that the DEC permit process is in the process of being approved.

Building Department Updates: VC Ryder reported that there was a total of 19 (nineteen) building and plumbing permits filed since the last Board of Trustees meeting on May 12th. There were also thirteen (13) inspections for the month of May.
