- Willow Pond Update: Deputy Mayor Oppenheimer reported that we need to speak to Dr. Abrams about a permit application consultant.

Building Department Updates: VC Ryder reported that there was a total of 14 (fourteen) building and plumbing permits filed since the last Board of Trustees meeting on October 18, 2022. There were also 22 (twenty-two) inspections for the month of October.
